

This Privacy Policy (“Privacy Policy”) applies to the data and communications of members and recent members of The Chandos Society of Artists.

Privacy Policy

The Chandos Society of Artists (the Society) values privacy – ours and yours. To help maintain your privacy and the security of your personal information, we communicate this and all of our privacy policies to the members of the Committee and we internally enforce privacy safeguards. We have implemented our GDPR compliance efforts with respect to our members.

Our Collection and Use of Information:

The Society may collect information in a number of ways from our website users and who communicate through email, online messenger services, post and primarily through enrolment to the Society..

Personal information (or “Personally Identifiable Information” or “PII”) is information and data that can be used to specifically identify or contact a single person. You will be asked to provide your personal information when you enrol with The Society do not share this information with any third parties without first obtaining the permission of the individuals. The term "personally identifiable information" means individually identifiable information about an individual member and may include any of the following:

1. A first and last name;
2. A home or other physical address, including street name and name of a city or town;
3. An e-mail address;
4. A telephone number;
5. Any other identifier that permits the physical or online contacting of a specific individual

Personal information we collect

Examples of some types of personal information Genesis Digital may collect in connection with the Sites and how we may use it include the following:

- We may collect a variety of information, including your name, mailing address, phone numbers, email address, contact preferences, and/or social media credentials. We do not collect data of bank and credit card details.

Cookies and Other Technologies

To help the Society serve you better, we use technological means to better understand and adapt to user behaviour. To accomplish this, the website, email messages, and advertisements may use cookies or related technology such as pixel tags, clear gifs, and web beacons. The data collected is used to improve our communication. We consider such information collected through the use of cookies and other technologies as non-personal information.

Children

Any information given to, or provided in communication with, a child must be in “such a clear and plain language that the child can easily understand”.

Where a child asks to join the Society, for which payment is normally made, parental consent will be required unless the child is aged 16 years or over.

The age at which a child can give their own consent under the GDPR, has been lowered to 13 years by the DPA 2018.

Personal Information Protection

We restrict access of personal information to our committee members who need to know that information in order to process it on our behalf.

You are solely responsible for any personal information you choose to submit.

GDPR

The RIGHT to KNOW and the RIGHT to BE FORGOTTEN: The GDPR gives you these rights and the Society enables every member to know what we know, and to ask us to 'forget' them.

"Cookies" and How We Use Them

A "cookie" is a small data file that can be placed on your hard drive when you visit certain websites. The website may use cookies to collect, store, and sometimes track information for purposes stated earlier as well as for statistical purposes to improve the products and services we provide.

Public Areas & Social Media

Any information you disclose in any public areas of our website or the Internet, including via social media becomes public information. You should exercise caution when deciding to disclose personal information in these public areas.
